Explanation: Starfish Africa's ("SA") core activity since inception has not changed -- SA transfers money to Kenya to sponsor talented but needy students. Starting in 2008, however, SA has started accounting for these transfers as Grants to Starfish Africa - Kenya ("SA-K"), a closely-related partner organization which is a registered NGO in Kenya. SA-K collects these grants and implements the SA mission on the ground in Kenya. SA-K's audited financials are submitted annually to the Kenya NGO Board. The grants cover tuition at elite schools, break activities (including computer camps and service projects), and the operating expenses for the program. SA has changed its internal accounting to reflect the existence of this registered NGO, and to more accurately reflect the grant process for SA-K. SA maintains very close oversight of SA-K's finances. In 2008, SA-K spent ~83 percent of SA's grants on tuition and break activities, ~11 percent on field officer stipends, and ~6 percent on operating expenses.
